

Newpark Comprehensive School Board of Management Agreed Report for School Community January 2023

Admission Policy

The Board approved amendments to the Admission Policy required in accordance with Section 62 of the Education (Admission to Schools) Act 2018 and the Education (Provision in respect of children with special educational needs) Act 2022, along with the addition of clarifying paragraphs in relation to late applications. The amendments will be brought to the attention of parents and guardians of students attending the school and to staff of the school for their information and comment prior to being forwarded to the Patron for approval.

Hockey Pitch Redevelopment

Negotiations between the project managers and the new contractors have progressed, and a revised scope of works has been finalised. Both Newpark and Avoca Hockey Club look forward to making a joint announcement shortly in relation to progress on this project.

One-to-One Devices

In light of ongoing consideration and reflection, it has been decided to introduce one-to-one devices for students, starting with first-year in September 2023. The introduction of one-to-one devices is intended to further enhance the progress that has been made in digital learning in the School over the last decade. Most importantly, it is intended that the incorporation of one-to-one devices will amplify existing pedagogical practice and add to both the learning and the assessment experiences of our students. Details in relation to the purchase of devices will be shared with parents and guardians of incoming first-year students at upcoming information sessions.

Student Wellbeing

Responding to and managing student anxiety within the School community is an important initiative under the School Improvement Plan this year, prompted by national evidence that young people's social and emotional skills and wellbeing have been adversely affected by the pandemic. The School is engaging Dr Claire Hayes, consultant clinical psychologist and author of *Finding Hope in the Age of Anxiety* to work with students, staff and parents/guardians. The PTA is funding and organising the parent/guardian presentation from Dr Claire Hayes on Tuesday 28th February 2023 and all parents and guardians are encouraged to register for and attend this event. Dr Claire Hayes will return in late March to work with students.

Six Sister Schools' Annual Conference

Newpark hosted the annual meeting of the Six Sister Schools under Church of Ireland patronage on 30th November and 1st December 2022. On the first day, Principals and Deputy Principals attended a session split between the sharing of School Self-Evaluation practices and a workshop with Dr Claire Hayes, while the annual meeting of the representatives of the Boards of Management took place on the second day. Both days were positively received by the participating schools, and all look forward to the conference next year, hosted by Temple Carrig School.



Mock examinations

Mock Leaving Certificate examinations are being held over ten days from Monday 30th January to Friday 10th February 2023. Mock Junior Certificate examinations are being held over eight days from Wednesday 1st February to Friday 10th February 2023. The sixth-year exams are being held in the gym during the first week and in classrooms during the second week. The third-year exams are being held in classrooms over the eight days.

Co-curricular Activities

There was significant success for the School at the recent BT Young Scientist & Technology Exhibition with three entrants at junior, intermediate and senior level. Three third-year students received a 'Highly Commended' award in the Chemical, Physical & Mathematical Sciences category for their project entitled, 'Fuelling Newpark with Food Waste'. A fifth-year student won second place (individual) in the Behavioural & Social Sciences category for her project entitled 'Do 18-yearolds have the cognitive ability to vote fairly?'. There has been a lot of other recent co-curricular successes in the academic, cultural and sporting domains, all of which can be read about in the upcoming edition of the *Newpark Newsletter* available shortly on the School website.
